REPORT

Comes now the City of St. Louis, Missouri (the "City"), by the City Counselor's Office of the City of St. Louis, Thomas J. Ray, City Counselor through and by Scott Lang Harper, Assistant City Counselor who states:

1. The City is a municipal corporation organized and operating under a constitutional charter adopted in 1914 and Article VI, Sections 31 - 33 of the Missouri Constitution of 1945.
2. The City is the owner and operator of Lambert-St. Louis International Airport (the "Airport").
3. The City acquired that portion of Washington Park Cemetery North of Interstate Highway I-70 and East of McDonnell Boulevard and situated along the eastern-most boundary of the Airport (the "Washington Park Cemetery-North") to facilitate Airport operations by removing restrictions on the use of Runway 12R-30L created by the Washington Park Cemetery.
4. Pursuant to a court order entered in this matter by Judge Harry J. Stussie and filed with this Court on April 12, 1996 (the "Court Order"), the City disinterred and relocated the human remains buried in Washington Park Cemetery-North.
5. The Court Order provides,


"[w]ithin ninety (90) days after the completion of the disinterment and relocation of all deceased persons within the portion of Washington Park

Cemetery-North, the City shall file a Report with this Court identifying the name and location (if applicable by section, lot and grave) of each deceased person disinterred from the Washington Park Cemetery-North, and the name of the cemetery and location (if applicable by section, lot and grave) where each such deceased person was reburied. The City of St. Louis shall cause copies of said Report to be filed with the Recorder of Deeds Office in both the City and County of St. Louis, Missouri;”

6. Attached hereto, incorporated herein, and labeled **EXHIBIT “A”** is the Report required by the Court Order.
7. Pursuant to the Court Order a copy of this Report has also been filed with the Recorder of Deeds Offices in both St. Louis City and St. Louis County.
